RANGE LOCATION: 4161 Lakemount Road, Abbotsford, B.C. or 5000 Harper Road, Coquitlam B.C.

RULES: Current CPCA rules shall govern.

COMPETITION OPEN TO: Any current member of CPCA. Non-CPCA members can purchase memberships

(\$45.00) at the time of registration. (\$60.00 with WA1500 participation)

ENTRY FEES: CPCA - 1ST Individual 1500 match (Revolver, Semi-auto or Optical), Additional

1500 matches (Revolver, Semi-auto or Optical and Duty Pistol match - \$5.00 all

inclusive.

Distinguished - matches. If fired, are \$5.00 each. All match fees include CPCA

registration fees.

All CPCA competitors must hold a valid 2025 CPCA membership which can be purchased along with match fees are payable on the day of the match upon

registration.

ENTRIES CLOSE: On the date of the tournament at 10:00 AM.

ENTRY LIMIT: 30 Competitors

FIRING STARTS: 10:00 AM on the day of each match fired at Abbotsford, Range is open at 09:30 for

range setup.

CLASSIFICATIONS: CPCA classifications will be used. Classifications from other associations may be

recognized at the discretion of the Match Sponsor and in keeping with current CPCA

rules.

TARGETS: The B-27 or WA1500 targets will be used at the discretion of the match director.

RANGE: The competition will take place on **Range 3**.

Parking at the Abbotsford range is accessed through the East gate. The range faces North and is outdoors with distances measured in yards with fixed targets at 25 & 50 yards. The firing lines for 3, 5, 7 and 15 yard lines are open to the weather while 25 and 50 yard courses of fire are covered with targets moved from the 25 to 50 yards as required. Weather conditions are unpredictable so make sure you come properly equipped.

SCORING: Competitors will score the targets of the competitor to their right. The scoring

location will be done at the discretion of the match director and will be done in the designated scoring area, or on the line. Scoring will be in keeping with CPCA rules.

A scoring (plug) may only be used by the official referee to determine the value of challenged rounds. The Official Referee, at their discretion, may use the device when the competitor has initiated a scoring challenge in accordance with the CPCA rules.

A competitor may only use a scoring overlay or magnifier for scoring.

CHALLENGE FEE: A challenge fee of \$2.00 per round and will be charged to competitors initiating a

challenge. The challenge procedure will occur as outlined in the CPCA rules.

EQUIPMENT & AMMUNITION: All equipment and ammunition will adhere to the CPCA rules.

RANGE DIRECTIONS: Eastbound take Trans-Canada Hwy #1. Eastbound to Whatcom Road. (Exit 95)

Head North on Whatcom Rd. Turn Right (East) on North Parallel Road. Turn Left (North) on McDermot Road. Follow McDermot around to Lakemount Road and the

range.

Westbound take Trans-Canada Hwy #1. Westbound to No. 3 Road (Exit 104), head North on No. 3 Road. Turn West (Left) on North Parallel Road. Turn Right (North) on No. 4 Road. Turn Right (North) on McDermot Road. Follow McDermot around

and veer left on Lakemount Road and the range.

Use East range gate to facilitate parking for Range 3
